This year marks the International Code Council's 30<sup>th</sup> anniversary as an international nonprofit dedicated to building safety, affordability and sustainability. With over 100 years of impact through its legacy organizations, the Code Council has driven the development and implementation of the International Codes® (I-Codes) in all 50 U.S. states and many other countries.

Formed on December 9, 1994, by its three legacy organizations and officially consolidated in 2003, the Code Council was created to develop a single set of comprehensive and coordinated model codes. To date, the I-Codes are the most widely used and accepted model codes available to support the built environment, impacting the safety of nearly 2 billion people globally. The I-Codes reference more than 1,600 standards developed by the Code Council and other standards developing organizations.

Since its formation, the Code Council has grown to offer a wide range of solutions to the building safety community. Currently, the Code Council has eleven offices in three different countries and is active in more than 100.

"Over the past 30 years, we have helped communities on a global scale create a safer built environment," said Code Council Chief Executive Officer Dominic Sims, CBO. "We remain committed to serving our members and customers — hundreds of thousands of dedicated building safety professionals who uphold public safety in communities across the world day after day — and we owe a debt of gratitude to them for the building codes and standards we have today."

# LEGISLATIVE WATCH LIST



HB 527(BR-140)(click bill number to view bill details.)

Create new sections of KRS Chapter 198B to define terms; establish licensing for roofing contractors under the Department of Housing, Buildings and Construction; prohibit any persons not licensed under this department from holding himself or herself out as a roofing contractor; authorize the department to promulgate administrative regulations; authorize the department to issue a license for roofing contractors; establish fee limitations; establish requirements for applicants; authorize the department to implement disciplinary actions; establish a fine for violations; create the roofing contractors fund; amend KRS 367.620 to conform

# HB 444(BR-1907)(click bill number to view bill details.)

Amend KRS 227A.060 to modify experience and education requirements for an electrician or master electrician license; require an electrician applicant or master electrician applicant to have 8,000 hours or 16,000 hours of verifiable experience, respectively, which may be reduced by designated education or teaching; authorize a master electrician or electrician applicant to qualify for licensure through teaching or attending an associate's degree or diploma program at a college within the Kentucky Community and Technical College System or at another accredited college or university; enable a military veteran to meet master electrician or electrician experience requirements through applicable supervised military occupational specialty experience; direct the department of Housing, Buildings and Construction to promulgate administrative regulations to establish an application form to allow submission of military experience; accept either a DD-214 form or a signed statement from the applicant's commanding officer to verify relevant military experience; amend KRS 227A.100 to renew electrician licenses once every two years; allow a licensee to request either a physical or electronic license.

# **LEGISLATIVE WATCH CONTINUED**



HB 472(BR-1866)(click bill number to view bill details.)

Create a new section of KRS Chapter 381 to allow the appointment of a receiver for a planned community when it fails to maintain the infrastructure, common area, storm water detention or retention area, or other facility that it is legally obligated to maintain; allow a city to recover funds expended to repair, renovate, maintain, or otherwise bring violations up to code.

# <u>SB 164(BR-154)</u>(click bill number to view bill details.)

Create new section of KRS Chapter 198B to allow articulation agreements between licensed proprietary schools and public school districts or state area technology centers to establish academic or training equivalencies needed to obtain licensure; require the Department of Housing, Buildings and Construction to recognize and honor the articulation agreements toward licensure in the professions regulated by the department, including electricians, plumbers, and HVAC.

# <u>SB 234(BR-1550)/LM(click bill number to view bill details.)</u>

Create new sections of KRS Chapter 100 to define terms related to short-term rentals; make owner-occupied short-term rentals a permitted residential use; permit non-owneroccupied short-term rentals to be subject to a conditional use permit or variance; permit regulation of short-term rentals in certain circumstances if enforcement is in the same manner as other properties; allow planning unit to require permitting for the operation of short-term rentals and enumerate the contents of a permit application, procedures for application, revocation of a permit, benefits of permit, and penalties for operating without a permit when planning unit has adopted a permitting ordinance; state that the Act shall not be construed to affect regulations of a homeowner's association or other similar property owner association; state that any ordinance that conflicts with provisions of the Act is unenforceable; provide that the Act may be cited as the Kentucky Short-Term Rental Regulation Act.

**<u>SB 368(BR-2406)</u>**(click bill number to view bill details.)

Create a new section of KRS Chapter 198B to define; require short-term rental platforms to prompt users listing properties through their platforms with information regarding R-1 residential occupancies and a box to check regarding whether the property is an R-1 residential occupancy; require short-term rental platforms to store information regarding properties listed as R-1 residential occupancies and to provide email notifications to the person listing the property and the Department for Housing, Buildings and Construction regarding the property; require the Department for Housing, Buildings and Construction to provide short-term rental platforms with information regarding R-1 residential occupancies and allow the Department to promulgate regulations to.

# HB 296(BR-1168)/LM(click bill number to view bill details.)

Amend KRS 198B.050 to exempt temporary structures from building code compliance if erected by or for a state or government agency, city, or municipality





# **Reviving History: Transforming Buildings with the International Existing Building Code**

The IEBC encourages the continued use and reuse of existing buildings, including historic buildings, by enabling changes in occupancy and use types without requiring full compliance with building features otherwise required for new construction.

February 26th, 2024 by International Code Council Technical Topics

This month, the Advisory Council on Historic Preservation (ACHP) adopted its Policy Statement on Housing and Historic Preservation which supports the International Code Council's International Existing Building Code® (IEBC) as a resource for building conversions. The ACHP Policy Statement follows an October 2023 White House launch of a new guidebook to facilitate commercial to residential conversions to address postpandemic office vacancies.

Created by the National Historic Preservation Act (NHPA), the ACHP is an advisory council that works to promote the preservation, enhancement and sustainable use of diverse historic resources in the United States.

"The Code Council welcomes ACHP's support for the role the IEBC can play in enabling building reuse—including of historic buildings, which present unique challenges," said Code Council Chief Executive Officer Dominic Sims, CBO. "With the increased interest in converting underutilized commercial buildings to residential, it's imperative that communities, design professionals and developers leverage the IEBC's flexibilities, which can facilitate their efforts through faster completions and generate cost savings."

Historic Conversions Using the IEBC

Revitalizing historic buildings offers significant advantages to communities, as it preserves their cultural heritage and architectural character. These converted spaces often serve as hubs for economic activity, attracting more businesses, tourists and investors, thus contributing to improved income opportunities.

Additionally, repurposed historic buildings offer versatile and unique spaces that can offer a wide variety of community needs, ranging from housing and commercial use to cultural and recreational venues, enhancing the overall quality of life in the area.

By adhering to the IEBC standards, repurposed historic buildings will undergo necessary upgrades to meet modern safety and accessibility requirements without compromising their original character while minimizing costs and construction timelines. The IEBC fosters sustainable development by reducing the environmental impact associated with new construction while simultaneously revitalizing existing areas.

**International Existing Building Code** 

The IEBC plays a crucial role in ensuring the safety and functionality of existing structures worldwide. By providing standardized guidelines and regulations, it helps maintain structural integrity, fire safety and accessibility in older buildings.



Adopted by 45 states, the IEBC encourages the continued use and reuse of existing buildings, including historic buildings, by enabling changes in occupancy and use types without requiring full compliance with building features otherwise required for new construction.
